25.36 TREASURER'S REPORT AND PRESENTATION OF ANNUAL ACCOUNTS

The accounts for the year ended 31 March 2025 had been presented and approved at the previous meeting and were presented to the meeting.

The accounts for the year produced a deficit of £20,950. A healthy bank balance had been built up over previous years, including healthy income in the previous year from bookings and fund-raising activities such as the coffee mornings. Bookings income has continued to improve with more ad hoc events and parties. The deficit is mainly due to the large, budgeted expenditure on resurfacing the car park, together with increased running costs in light, heat and fuel. Water and cleaning have both decreased.

The bank balance at the end of March 2025 is still very healthy at £15,529, and we manage to maintain over and above our reserve funds of £10,000, which we will continue to build on for any future repairs and maintenance to be done.
